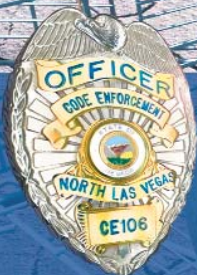




ABANDONED SHOPPING CART CLEANUP PROGRAM

Your Guide to rid the City of abandoned shopping carts.

STATED PURPOSE

The purpose of the City of North Las Vegas shopping cart ordinance is to rid the City of abandoned shopping carts. Abandoned carts create a potential hazard to the health and safety of the public and interfere with pedestrian and vehicular traffic.

OVERVIEW

Effective January 2003, any abandoned shopping carts on public or private property may be removed by the City or its agent and returned to the cart owner.

RETAILER REQUIREMENTS

Shopping cart owners are required to provide ongoing measures to prevent removal of, or ensure prompt retrieval of, shopping carts.

FINES & FEES

An impound fee (\$3.00 per cart) will be assessed against the shopping cart owner plus an administrative fee of 15% of the actual cost to the City for retrieving and transporting the shopping cart. Businesses can be fined \$25.00 per day for failure to comply with the ordinance.

HOW TO LAWFULLY REMOVE A SHOPPING CART FROM A RETAILER

For residents who need to remove a shopping cart from a retailer, they may do so as long as they have a letter from the shopping cart owner giving them permission. It is the responsibility of the person removing the cart to return it to the store.

HOW TO REPORT AN ABANDONED SHOPPING CART

The City has contracted with California Shopping Cart Retrieval Corp. to facilitate the retrieval and removal process. Abandoned shopping carts can be reported by calling either the California Shopping Cart Retrieval Corp at 1-800-252-4613 or the City of North Las Vegas at 633-1677.
